The Cease and Desist was sent via certified mail/return receipt requested and first class mail on January 4, 2012 by the town attorney. It was mentioned that a certain amount of time needs to pass to enable the Halls the opportunity to receive the correspondence. If the return receipt request does not get signed, it is assumed the Halls have the information and at that point the attorney will move forward with any necessary action.

BEDARD GRAVEL PIT

It was discussed that no additional information has been received. The Board discussed their frustration with the amount of time that has passed with no progress. It was mentioned that the town attorney needs to take some action to find closure in this case. Dave suggested that the Planning Board and the Selectment work together to put pressure on the town attorney to take the necessary steps to end this case. Merry made a motion to have Chet and Melanie draft a letter to send to the Selectmen requesting a joint meeting between the Selectmen, the Planning Board and the town attorney to discuss the Bedard issue in person; Mike seconded.
